Therefore, students studying here are expected to, above all, have an open attitude towards others, an open mind respectful of other cultures, an active interest in other cultures, a flexible mindset regarding unknown phenomena, and a strong orientation toward logical thinking.

5. Application requirements

General selection: Persons who qualify for any of the below categories (1-8).

Professional special selection: Persons who qualify for any of the below categories (1-8) and

<u>meet (A) or (B).</u>

- (A) A person who works at a government office, company, office, organization, school, etc., and aims to perform their doctoral studies while working.
- (B) A person with a master's degree or professional degree that was obtained three or more years before the time of enrollment.

International student special selection: <u>Persons who qualify for any of the below categories</u> (1-8) and who do not have Japanese citizenship.

- 1. A person who has a master's degree or a professional degree or who is expected to acquire one by September 30th, 2018.
- 2. A person who has been granted a master's degree or a professional degree in a foreign country or who is expected to acquire one by September 30th, 2018.
- 3. A person who has completed a program of an educational institution while living in Japan which is recognized by his or her country as having a curriculum of a graduate school under the said country's education system and which is designated separately by the Minister of Education, Culture, Sports, Science and Technology and who has been granted a degree equivalent to a master's degree or a professional degree or is expected to acquire one by September 30th, 2018.
- 4. A person who has completed subjects classes offered through a distance learning system by a foreign school while living in Japan and has been granted a degree equivalent to a master's degree or a professional degree or is expected to acquire one by September 30th, 2018.
- 5. Those who have completed a program at the United Nations University, which was established pursuant to a resolution adopted by the United Nations General Assembly on December 11, 1972, and is prescribed in Article 1, Paragraph 2 of the Act on Special Measures Incidental to Enforcement of the "Agreement between the United Nations and Japan regarding the Headquarters of the United Nations University" (Act No. 72 of 1976)

(hereinafter referred to as the "United Nations University"), and has been conferred a degree equivalent to a master's degree or is expected to acquire one by September 30th, 2018.

- 6. Persons designated by the Minister of Education, Culture, Sports, Science and Technology (September 1st, 1989 Ministry of Education Public Notice No. 118) Persons who:
 - * after graduating from a university, completing a sixteen year curriculum at a school

in a foreign country, or completing a foreign country's sixteen year curriculum by taking courses that are part of distance education administered by the foreign country's school,

* have engaged in research for two or more years at a university, research institute, etc.,

* and, based on these research results, etc., are recognized by the Graduate School of Human and Socio-Environmental Studies as having academic abilities the same as or greater than persons holding a master's degree or professional degree.

- 7. A person who will reach 24 years of age by September 30th, 2018 and is recognized as having academic ability equivalent to or more of that of persons having a master's degree or a professional degree as a result of individual screening by the Graduate School of Human and Socio-Environmental Studies.
- 8. Persons who have taken educational program by a school in a foreign country, an educational institution with a designation under Item 3, or the United Nations University and who has passed tests and examination prescribed in Article 16, Paragraph 2 of the Standards for the Establishment of Graduate Schools or is expected to do so by September 30th, 2018, and who is recognized by Graduate School of Human and Socio-Environmental Studies to have an academic ability equivalent to or more of that of persons having a master's degree.

5. Applicants wishing to apply based on application qualification (6), (7), or
(8) will undergo an application qualification screening before they submit their application. Please refer to Application qualification screening below.

Regarding the "Graduate School Establishment Standards Article 14-based Educational Methods Special Case" System

The Graduate School of Human and Socio-Environmental Studies has instituted a "Graduate School Standards Article 14-based Educational Methods Special Case" system. It may be used by persons who are working and some others. Through this system, such persons can, with the permission and under the guidance of their advisor, flexibly engage in their studies based on the educational curriculum prescribed in the Graduate School of Human and Socio-Environmental Studies' Regulations, etc.

Article 14. In graduate school courses, if educationally necessary, education can be carried out based on suitable methods in which, for example, classes or research guidance are carried out at night or other specified times or periods.

This system does not fall under Article 2.2 (Graduate Schools Courses Carrying out Education Solely at Night). The Graduate School of Human and Socio-Environmental Studies holds classes, etc., during the day and at night.

Application qualification screening

Persons who wish to apply based on application qualification (6), (7), or (8) will undergo an application qualification screening before they submit their application. Please first contact the school and then submit, to the Admission Section (Student Affairs Division, Human and Social Administration Department), the materials listed in "6. Requesting Application Materials and Application Procedures" (excluding the proof of application fee bank transfer payment) so that they arrive by 5:00 PM on June 4th (Monday), 2018.

If sending materials by postal mail, please write the following in red on the envelope: "Doctoral Application Qualification Screening Materials."

If the applicant is recognized as having academic abilities the same as or greater than

persons with a master's degree or professional degree, these submitted materials will be accepted as the application materials specified in "6. Requesting Application Materials and Application Procedures." If the applicant is informed that they have passed the application qualification screening, they should pay the application fee and submit the designated proof of application fee bank transfer payment to the Admission Section (Student Affairs Division, Human and Social Administration Department) during the application period.

9. Applicant selection method

General selection, professional special selection,

international student special selection

Selection will be carried out based on the results of the screening (oral examination, research plan, submitted articles, etc. and application materials).

The oral examination will focus on the master's thesis (or article abstract, research article, survey/research report, etc.) and research plan.

Applicants may be asked about their abilities in foreign languages that are needed for research.

Professional special selection applicants may also be asked about the specialized knowledge they gained from their professional experience. International special selection applicants may be asked about Japanese language abilities in the case that such abilities are needed in their research.

11. Enrollment procedures

(1) Enrollment procedures

Please enroll by the specified date using the "Graduate School Enrollment Procedures Guidelines" that will be sent after successful applicants are announced.

- (2) Payment of tuition and other fees
 - (a) Enrollment fee: ¥282,000

The following individuals do not need to pay the enrollment fee: individuals who, after completing a Kanazawa University graduate school master's program in September 2018, will directly enroll in the doctoral program, and Japanese government scholarship international students.

(b) Tuition (second semester): \$267,900 (year total: \$535,800)

(Notes)

- 1. The above prices are tentative. If the enrollment fee or tuition is changed before or after enrollment, the new price will be applied.
- 2. Tuition is paid via direct debit. It will be automatically deducted from the bank account specified by the student on the specified date.
- 3. Japanese government scholarship international students do not pay tuition.

(c) Disaster and accident insurance for student education and research: ¥2,600 (three years)

12. Protection of Personal Information

Kanazawa University properly manages and protects the personal information it holds based on the Act on the Protection of Personal Information, Kanazawa University Management Regulations, etc.

Extended enrollment

Students can take courses while continuing to handle other life responsibilities.

The Graduate School of Human and Socio-Environmental Studies offers a long-term enrollment system for people with other responsibilities such as housework, child-rearing, caring for family members, and so on. Through this system, the student's enrollment period can be extended within the limit set in the school's regulations (generally six years at the doctoral level). This provides diverse and flexible learning opportunities for professionals' and others' academic needs.

Tuition is the same as the standard course of study (doctoral level section: three years) and can be paid in parts while enrolled.


