Guidelines for Applicants for the Selection Examination in English

The Division of Law and Politics of the Graduate School of Human and Socio-Environmental Studies offers an entrance examination in English for foreign students applying to the master's degree program. By offering an examination in English, the Graduate School of Human and Socio-Environmental Studies hopes to recruit a few talented and diligent students committed to pursuing a post graduate degree at a Japanese university, but whose level of Japanese proficiency remains insufficient to pass the regular entrance exam in Japanese. Applicants who successfully pass this entrance examination enter the Graduate School in October 2018 or April 2019.

1. Admission Policy

The Division of Law and Politics aims to analyze various ongoing legal, political and administrative phenomena concretely and empirically via precedent and case studies, and to ascertain the detailed characteristics of such phenomena through comparative international studies and historical and theoretical studies. Candidates for this course are required not only to master basic and technical knowledge in the areas they would like to major, as well as in related areas, but also to have a strong consciousness of the problems that society is facing now. Based on this background, all candidates for this course are evaluated not only on the degree of achievement of the above-mentioned *basic and technical knowledge* through a written examination of the specialized subjects, including those in the major subject area after admission, but also their level of consciousness of the problems of the public at large through an oral examination.

2. The number to be admitted: a few

3. Qualifications for applying:

Those who fall under any of the following categories or are expected to fall under such categories by September 30, 2018 (or by March 31, 2019 if the applicant will enter the Graduate School in April 2019) shall qualify.

- (1) A person who has graduated from a university described in Article 83 of the School Education Act (No. 26 of 1947 Act).
- (2) A person who has been granted a bachelor's degree pursuant to the provisions of Article 104, Paragraph 4 of the School Education Act.
- (3) Persons who have completed a 16-year course of school education with a regular curriculum in a foreign country.
- (4) A person who has completed a course of an educational institution in Japan which is recognized by his or her country as having a curriculum of a university under the said country's education system and which is designated separately by the Minister of Education, Culture, Sports, Science and Technology.
- (5) A person who has, while living in Japan, completed a 16-year course under the said foreign country's education system by taking subject classes of a foreign school through a distance learning system.
- (6) A person who has been granted an academic degree equal to a bachelor's degree in

foreign university or other institution (limited to those institutions that have been evaluated by the government or by persons who have the approval of foreign government or relevant organizations or designated separately to be an equivalent by the Minister of Education, Culture, Sports, Science and Technology in terms of comprehensive status of the education and research activities, etc.) by completing a program having a duration of study of 3 years or more (including those who have completed subject classes under a distance learning system offered by a foreign school while living in Japan or have completed a program at an educational institution in Japan that is part of the school education system of the specific country and that is separately designated by the Minister of Education, Culture, Sports, Science and Technology).

- (7) Persons designated by the Minister of Education, Culture, Sports, Science and Technology.
- (8) Persons who have completed a higher course of a specialized training college (restricted to a college having 4 years or longer of a duration of study and that satisfies the standards determined by the Minister of Education, Culture, Sports, Science and Technology) separately designated by the Minister of Education, Culture, Sports, Science and Technology on after a day decided by the Minister of Education, Culture, Sports, Science and Technology.
- (9) A person who has enrolled in a graduate school of other university pursuant to the provisions of Article 102, Paragraph 2 of the School Education Act and then who is recognized to have appropriate abilities to receive graduate school education at a graduate school of Kanazawa University (hereinafter referred to as the "University").
- (10) A person who has enrolled in a university described in Article 83 of the School Education Act for 3 years or more, a person who has completed a 15 years of school curriculum in a foreign country, a person who has completed in Japan a program of an educational institution which is recognized to have 15 years of school curriculum of the country under the school education system of the foreign country and which is designated separately by the Minister of Education, Culture, Sports, Science and Technology, or a person who has completed a 15 years of program under the education system of a foreign country by taking subject classes through a distance learning system provided by a school in the foreign country while living in Japan and who is recognized as having acquired prescribed number of credits with superior grades in a graduate school of the University.
- (11) A person who has reached 22 years of age and is recognized as having academic ability equivalent to or more of that of persons described in Item 1 as a result of individual screening by a graduate school of the University.

[Note] In the event of (11), the following candidates will be recognized as qualifying through individual screening.

Persons who qualify for special admission to the third year of university, are aged 22 or older at the time of admission, and fall within any of the following categories:

- (a) A person who has studied in an advanced course at a junior college or technical college, etc., after having qualified for special admission to university;
- (b) A person who has work experience or other experience in activities with international organizations and other institutions in an overseas country
- (c) A foreign student who has been in a Graduate School or the School of Law as a research student for a given period and has sufficient academic skills to qualify for the master's course of the Graduate Schools of Human and Socio-Environmental Studies.

4. Preliminary examination of Qualifications:

Those who would like to apply under 3. (9), (10), (11)(a), (b), or (c) above are asked to submit the following materials to Admission Section, Student Affairs Division, Human and Social Administration Department, Kanazawa University by May 18, 2018 (Fri). When submitting materials by mail, "Application for Preliminary Examination of Qualifications, Graduate School of Human and Socio-Environmental Studies (Master's Level Section)" should be written in red on the front of the envelope.

- (1) Application Form for Preliminary Examination of Qualifications (A form designated by the Graduate School of Human and Socio-Environmental Studies)
- (2) Graduation (completion) certificate or a certificate of prospective graduation (completion) issued by the applicant's last school
- (3) Transcript issued by the applicant's last school
- (4) Curricula and syllabi of the applicant's last school or copies of equivalent documents
- (5) Curriculum vitae (A form designated by the Graduate School of Human and Socio-Environmental Studies)
- (6) A certificate of enrollment that shows that the applicant has experience in business or experience in activities (if applying under 3. (11) (b)) (in any form)
- (7) A document that describes the business or activities (written by the supervisors of such activities, if applying under 3. (11) (b)) (in any form)
- (8) Research plan document: Explanation of the applicant's research plan at the Graduate School, the relationship to past work experience or activities, and hope for the future. (A form designated by the Graduate School of Human and Socio-Environmental Studies)
- (9) Return envelope (standard-size, self-addressed and, in the case of domestic applicants, self-stamped with 792 yen in postage [registered express mail])

Note 1: The candidates will be notified of the results by the end of May 2018. Any materials submitted will not be returned.

Note 2: Certificates and documents issued by foreign schools or organizations must be submitted with a Japanese or English version and a briefing document.

[Note] Applicants qualifying under category 3. (11) (c) are not required to submit items specified under 5. (2), (3), and (6).

6. Application Procedure

- (1) Applicants should submit all application materials together.
- (2) When submitting application materials by mail,, they should be sent by registered express mail, with “Application for Graduate School of Human and Socio-Environment Studies (Master’s Level Section)” written in red on the front of the envelope.

- (4) Incomplete Applications will not be accepted.
- (5) Personal information contained in the application materials will be used only for
the purpose of this entrance examination.

7. Selection method

(1) Written examination:

The examination is conducted in English. It consists of answering questions on the subject chosen by the examinee from among the following: Commercial Law; Criminal Procedure; Foreign Law (Anglo-American Law); History of Political Thought; Intellectual Property Law; International Law; Jurisprudence; Polimetrics; Political Communication; Private International Law/International business Law; Public Policy; Social Security Law and Theories of Policy-Making Process.¹

If successful, the subject chosen by the examinee will become his/her major in the Graduate School. The examinee may bring one or more dictionaries for use during the exam.

(2) Oral examination:

Conducted in English, this exam covers the subject chosen by the examinee and the research plan he/she submitted.

8. Application for Short-term Visa

Applicants should pay special attention to the following points if applying for a short-term visa with the Japanese embassy or Japanese consulate in their country to take the entrance examination.

- (1) The Graduate School of Human and Socio-Environmental Studies cannot issue the documents required for the issuance of a visa such as a letter of personal reference, a schedule of stay, a statement of reason for the invitation, or a guarantor's certificate of employment.
- (2) If an applicant is not able to acquire a short-term visa for the examination after following the examination application procedure, the examination fee will not be returned. Please confirm the requirements for acquisition of a short-term visa well in advance at the Japanese Embassy or Japanese Consulate.

12. Admission and Tuition Fees

- (1) Admission Fee: ¥282,000; Tuition: ¥267,900 (for the first semester or ¥535,800 for two semesters); Accident Insurance: ¥1,750 (for two years). Admission and Tuition Fees may change in accordance with circumstances.
- (2) Notice: Following submission, applications cannot be modified or withdrawn and fees are non-refundable. If an application is found to contain false statements, admission may be canceled. In that case, admission fees, once paid, are not refunded for any reason. Applicants are advised to make sure that the date for the admission procedures is strictly fixed. If successful applicants fail to follow the admission procedures by that date, they will be considered to have declined their admission.

Outline of Master's Degree qualification requirements

The Division of Law and Politics of the Graduate School of Human and Socio-Environmental Studies consists of four programs: Basic Science of Law; Public and Social Law; Private Law; and Politics. The student must select the program in which his/her major is included.

The master's degree is awarded to a student who has satisfied the following requirements:

1. At least two years in residence in the master's course;
2. Acquisition of the credits set out below (Tables 1 and 2); and
3. An acceptable master's thesis written under the guidance of a faculty member.

金沢大学大学院人間社会環境研究科(博士前期課程)法学・政治学専攻では、外国人留学生のため、英語による特別選抜を行います。英語による選抜は、日本語での試験に合格するには日本語能力が十分ではないが、日本の大学で修士の学位取得を目指す有能な外国人留学生を募集することを目的としています。本選抜による合格者は2018年(平成30年)10月または2019年(平成31年)4月に入学します。

1. 学生受入方針(アドミッション・ポリシー)

法学・政治学専攻は、現在進行しつつある様々な法的・政治的・行政的諸現象について、判例研究や事例研究を通して具体的・実証的に分析し、そのような諸現象の特質を国際的比較研究や歴史理論研究により深く究明することを目的とします。本専攻の志望者には、専攻しようとする分野ならびに関連分野に関する基礎的専門知識の修得は勿論のこと、社会に対する強い問題関心を有していることが求められます。このような観点から選抜試験においては、入学後専攻しようとする専門科目の筆記試験によって、上述の「基礎的専門知識」の到達度を試されるとともに、口述試験を通じて社会全般に対する問題関心の有無が問われることとなります。
